10. RESEARCH – *Todd Cornwell*

Steve Kujak – is our liaison.

- 10.1. Research project update – work statement on Investigation into sensible temperatures for potable hot water temperatures to maximize public safety, water and energy conservation. RAC met and “returned” back to committee on confusion for why we need the research... could the committee do it on their own. Also felt \$ amount was high for a research of literature. Phone conference in March if we can submit before that. Todd to work with group (Tim K, Alain T, Ron G, Claressa, Jeff B,) and with Steve Kujak to resubmit. Steve suggested we don't focus on too many co-sponsors – this can delay due to increased voting at committees. Helen thanked Steve to support this project.
- 10.2. Research project ideas for two other potential projects:
 - 10.2.1. Secondary Disinfection Methods – Similar in scope and methods for the NCD projects to test different methods of secondary disinfection (bleach, monochloramine, CuAg, clo2, others?) – Janet stated that the debate continues on efficacy (or lack of), decisions on hot water vs. cold water systems. Project to provide data on: Measuring kill rate, but also corrosion, by products, etc... - Proposal Evaluation Subcommittee. Todd to spearhead – Josh Ince, Alain Trahan, Tim Keane, Arthur F, Janet Stout, Joe Ham, Jim K, John Cohen
 - 10.2.2. Compendium on regulations by state – Todd to work on this and circulate draft RTAR to the full committee. Review of regulatory landscape by state on requirements for adding secondary disinfection and corrosion inhibitors in a building.

11. LIAISON REPORTS – ASHRAE / AWT / CTI / OTHERS

- 11.1. Relevant Codes and Standards Reports
 - 11.1.1. ASHRAE Guideline 12 – Helen C reported that the committee reviewed over 600 comments (in November 2017). Now working on second document being worked on to be sent to public review.
 - 11.1.2. CTI Guideline 159 - Working group chair, H. Cerra reported – waiting on one section.
 - 11.1.3. ASHRAE Standard 189P – Daryn Cline made comments regarding addendum that was rejected regarding models and material for CT. Being re-written and submitted for comments. This addendum will probably make 2020.
 - 11.1.4. ASHRAE Standard 191P – A. Troisi discussed 191 went for public review. Originally included all water usage in building water system - that scope has been narrowed. This is now an HVAC/Cooling System based standard. 110 comments from public review. 70 editorial, remainder were in opposition of the standard being published. Standard committee met to work on a process toward 2nd public review. Reorganize the standard, and bring irrigation back in.

11.1.6. ASHRAE Standard 90.1 – F. Morrison discussed potential proposal on doubling efficiency. Adding dry cooler requirements. Next edition is 2019. Title 24 is moving to 45 day review. Increased efficiency to 60 gpm per HP. Strengthened the limits on air cooled chillers. Requirement for adiabatic condensers. Change pending ASME pressure boiler code – CTI, 8.6, providing comment on this.
